RELEASE, WAIVER OF CLAIM, AND ASSUMPTION OF RISK WARNING
PLEASE READ CAREFULLY

The Lethbridge Therapeutic Riding Association will be referred to as "LTRA".

The Rider or legal guardian, (hereafter referred to as the Rider) acknowledges that activities undertaken at LTRA facilities and/or any offsite sanctioned event has inherent risks. LTRA will endeavour to provide reasonable services and to act reasonably, although LTRA is not able to assure that the services it provides will meet all needs or provide a trouble free or risk free experience.

The Rider releases LTRA, its directors, agents and employees from all liability and waives, as against LTRA, its directors, agents and employees all recourse, causes of action or claims of any kind for loss or damages, including any consequential loss or damage, and voluntarily accepts the legal risk, therefore expressly giving up any right of action from the physical risk arising from any actions initiated by the undersigned or, by anyone who is not affiliated with LTRA, who is acting on the undersigned's behalf.

The Rider further acknowledges and agrees that:

- Equestrian activities can be very dangerous and expose all participants or observers to many risks and hazards, some of which are inherent in the very nature of the sport.
- As a result of the aforementioned risks and hazards, the rider may suffer personal injury, property loss or even death as a result of their presence or actions at LTRA and/or any offsite sanctioned event.
- Some of the risks and hazards are foreseeable, but many others are not.

The Rider nevertheless, freely and voluntarily assumes all possible risks, and hazards and acknowledge that their riding in this event while participating in or observing any activities, shall be entirely at their own risk, or at the risk of those for whom they are a guardian or caregiver. The rider understands that LTRA its directors, agents and employees do not assume any responsibility or liability whatsoever for their actions while observing or engaged in any of the activities in any way.

By signing this Release, Waiver of Claim and Assumption of Risk Warning, the Rider will be FOREVER PRECLUDED FROM SUING OR OTHERWISE CLAIMING AGAINST LTRA, its directors, agents and employees for any loss or damage or injury or death they may sustain as a result of their own actions.

The Rider agrees to indemnify and hold harmless LTRA, its directors, agents and employees from any and all 3rd party claims initiated as a result of any act or omission of the undersigned or anyone for whom the undersigned is a guardian, for events alleged to have occurred at this event.

The Rider understands that LTRA intends all users or observers of activities at this event sign this Release, Waiver of Claim and Assumption of Risk Warning. The Rider has carefully read and accepts the terms of this Release, Waiver of Claim and Assumption of Risk Warning and acknowledges that no representation of fact or opinion, threat or inducement has been made or given by LTRA, its directors, agents or employees to induce the signing of this Release.

This Release, Waiver of Claim and Assumption of Risk are binding upon me, my heirs, my executors, administrators, personal representatives, and assigns.
